FRANKLIN COUNTY FISCAL COURT AUGUST 30, 2018 5:00 P.M. REGULAR MEETING

Franklin County Fiscal Court met on Thursday, August 30, 2018 in the Fiscal Court Room at 321 West Main Street, Frankfort, KY. The meeting was called to order at 8:06 p.m. with Judge Huston Wells presiding.
