

ORDINANCE No. 3 - 2013

AN ORDINANCE AMENDING ORDINANCE NO. 3-2012 AND ORDINANCE NO. 9, 2007 SERIES, RELATING TO FLOOD DAMAGE PREVENTION ORDINANCE, ARTICLE 3, SECTION B, BASIS FOR ESTABLISHING THE SPECIAL FLOOD HAZARD AREAS

WHEREAS, The Franklin County Fiscal Court desires certain changes to be made to the ordinance establishing standards and procedures for the prevention of flood damage to assure that federal flood insurance continues to be provided;

WHEREAS, revised flood insurance rate maps have been provided for Franklin County, Kentucky which requires the ordinance be amended to reflect the effective date of said maps;

WHEREAS, The Frankfort/Franklin County Planning Commission held a public hearing on March 21, 2013 and adopted a summary of the evidence and recommended approval of the text amendment, as required by K.R.S. 100;

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF FRANKLIN, COMMONWEALTH OF KENTUCKY, AS FOLLOWS:

That Ordinance No. 3-2012 adopted March 1, 2012, and of record in Fiscal Court Order Book 24, page 379, and Ordinance No. 9, 2007 Series, adopted September 28, 2007, and of record in Fiscal Court Order Book 22, Page 148, the Flood Damage Prevention Ordinance, Article 3, Section B, Basis for Establishing the Special Flood Hazard Areas, is hereby amended and readopted to read as follows:

ARTICLE 3. GENERAL PROVISIONS

SECTION B. BASIS FOR ESTABLISHING THE SPECIAL FLOOD HAZARD AREAS

The areas of special flood hazard identified by the Federal Emergency Management Agency (FEMA) in the Flood Insurance Study (FIS) for Franklin County, dated ~~September 28, 2007~~ June 18, 2013, with the accompanying Flood Insurance Rate Maps (FIRMS), other supporting data and any subsequent amendments thereto, are hereby adopted by reference and declared to be a part of these regulations. This FIS and attendant mapping is the minimum area of applicability of this ordinance and may be supplemented by studies for other areas which allow implementation of this ordinance and which are recommended to the Fiscal Court by the Floodplain Administrator and are enacted by the Fiscal Court pursuant to statutes governing land use management regulations. The FIS and/or FIRM are permanent records of Franklin County and are on file and available for review by the public during regular business hours at the Franklin County Planning and Zoning Office.

INTRODUCED AND GIVEN FIRST READING IN SUMMARY at a duly convened meeting of the Fiscal Court of Franklin County, Kentucky, held on the 25 day of April, 2013.

GIVEN SECOND READING AND APPROVED at a duly convened meeting of the Fiscal Court of Franklin County, Kentucky, held on the 17 day of May, 2013 and of record in Fiscal Court Order Book 25, Page ~~213~~ 214.

This Ordinance shall take effect and be in full force when passed, published and recorded according to law.
