## ORDINANCE NO. \_\_\_\_ - 2011

## AN ORDINANCE RELATING TO THE REAPPORTIONMENT OF MAGISTERIAL DISTRICTS

Whereas, on May 16, 2011, the Fiscal Court of Franklin County, Kentucky, initiated reapportionment proceedings of the six magisterial districts pursuant to KRS 67.045;

Whereas, the Franklin County Fiscal Court appointed three competent citizens of the county, over 21 years of age, who resided in different districts and the County Clerk as an exofficio member to the Franklin County Reapportionment Board;

Whereas, the Commissioners have filed in the office of the County Clerk and with each member of the Fiscal Court a written report showing the boundary of each district and the estimated population in each district;

Whereas, at its meeting on July 12, 2011, Franklin County Fiscal Court did receive the reapportionment report of the Commissioners;

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF FRANKLIN, COMMONWEALTH OF KENTUCKY, that the following six (6) magisterial districts are reapportioned by precinct as follows:
