

ORDINANCE NO. 7 - 2011

**AN ORDINANCE RELATING TO THE REAPPORTIONMENT  
OF MAGISTERIAL DISTRICTS**

Whereas, on May 16, 2011, the Fiscal Court of Franklin County, Kentucky, initiated reapportionment proceedings of the six magisterial districts pursuant to KRS 67.045;

Whereas, the Franklin County Fiscal Court appointed three competent citizens of the county, over 21 years of age, who resided in different districts and the County Clerk as an ex-officio member to the Franklin County Reapportionment Board;

Whereas, the Commissioners have filed in the office of the County Clerk and with each member of the Fiscal Court a written report showing the boundary of each district and the estimated population in each district;

Whereas, at its meeting on July 12, 2011, Franklin County Fiscal Court did receive the reapportionment report of the Commissioners;

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF FRANKLIN, COMMONWEALTH OF KENTUCKY, that the following six (6) magisterial districts are reapportioned by precinct as follows:
