FRANKLIN COUNTY FISCAL COURT APRIL 25, 2017, 3:00 P.M. SPECIAL MEETING

Franklin County Fiscal Court met on Tuesday, April 25, 2017 in the Fiscal Court Room at 321 West Main Street, Frankfort, KY. The meeting was called to order at 4:17 p.m. with Judge Huston Wells presiding. Following roll call and pledge of allegiance, motion by Squire Sturgeon, seconded by Squire Goins, for authorization for approval of minutes from special meeting of March 29, 2017. Motion by Squire Moore, seconded by Squire Turner, for authorization to approve County Clerk's Claim for Calculation of Motor Vehicle and Boat Bills for 2017 to be paid by Fiscal Court in the amount of \$7,520.40.
