Amended Sunday Sales Ordinance

Effective immediately, Franklin County has amended the times of operation to allow increased hours of sale on Saturday nights and to allow increased hours of sale on Sunday, as well as now permitting sales of alcoholic beverages both by the drink and by package on Sundays. Please see the table below for an explanation of the older and the new sales hours and restrictions:

Expanded Sunday Sales Requirements

If you are a package retailer no other license is necessary for you to sell on Sundays during the prescribed times listed above. If you sell by the drink but until now have not qualified for a Sunday Sales License because you are not a restaurant you are now eligible for a Sunday Sales License and MUST apply for and receive a Sunday Sales license from the KY ABC and Franklin County prior to selling during the prescribed Sunday sales time.
