2020-2021 ALCOHOL BEVERAGE LICENSE RENEWAL NOTICE

BY ORDER OF THE GOVERNOR – ALL COUNTY ABC LICENSES EXPIRING ON
JUNE 30TH HAVE BEEN EXTENDED TO EXPIRE ON AUGUST 31, 2020

YOU MAY RENEW AT ANY TIME UP TO OCTOBER 31ST

Failure to renew by October 31st constitutes a violation and subjects the licensee to suspension or revocation

To renew your County Alcohol Beverage License: Submit a copy of your 2020 State Alcohol License and your Mandatory Responsible Beverage Service Training (RBST) Certificate or an affidavit to the County Clerk's Office. You must pay by check, money order, debit card (\$2.50 fee) or credit card (3% fee). **The County Clerk is NOT accepting CASH.** The County Clerk's Office is located at 315 West Main Street, and current office hours are Monday thru Friday, 9:00 a.m. – 3:00 p.m.

**Per KRS 243.060 (4) The holder of a nonquota retail malt beverage package license may obtain a Nonquota type 4 malt beverage drink license for a fee of \$50.00. The holder of a Nonquota type 4 malt beverage drink license may obtain a nonquota retail malt beverage package license for a fee of \$50.00.*

***Per KRS 243.060 (3) The fee for each of the first five (5) supplemental bar licenses shall be the same as the fee for the primary drink license. There shall be no charge for each supplemental license issued in excess of five (5) to the same licensee at the same premises. (Limited Restaurant, Limited Golf Course, Quota Retail Drink, NQ2 Retail Drink, NQ3 Retail Drink).*
