## FRANKLIN COUNTY FISCAL COURT VIDEO TELECONFERENCE MARCH 3, 2022 5:00 P.M. REGULAR MEETING

Franklin County Fiscal Court met by video teleconference on Thursday, March 3, 2022. The meeting was streamed live by Frankfort Plant Board, cable channel 10, Franklin County Fiscal Court's Official Facebook page, www.facebook.com/fcfcky and Franklin County Fiscal Court's Official YouTube channel, www.tinyurl.com/fcfcky. The primary location of the video teleconference was 321 West Main Street, where all members of fiscal court could be seen and heard with a public observation area in the work session conference room.
