Re: 2023 Open Enrollment Period will be October 24- November 4, 2022

## All Changes Are Effective January 1, 2023

Outside of the Open Enrollment window, you may only enroll, cancel or change coverage during the plan year of January-December 2023 by meeting one of the following qualifying events: new employee, marriage, divorce, death of spouse or child, birth or adoption of child, employment status change of employee or spouse, resignation or retirement.

## All full-time (1560 or more hours annually) employees <u>MUST</u> complete a Franklin County Fiscal Court Election Form for 2023 regardless of participation.

If you decline participation, please sign the bottom of page 2 under "I decline participation".

If <u>no changes</u> are needed, please complete the form by marking your current coverage, (you can look at your last pay stub for that information) initial both areas under **additional terms**, sign and date under **authorization**.

<u>Flexible Spending Account - Health Reimbursement Arrangement (waiver) - Dependent Care Account participants must complete a new McGregor & Associates form.</u>
