The meeting was made available for video teleconference (VTC) participation with the primary location and public observation area in the Fiscal Court Conference Room located at 321 West Main Street.

The meeting was called to order at 11:25 a.m. with Judge Huston Wells presiding. The following members of Fiscal Court were present: Squire Sherry Sebastian, Squire J.W. Motion by Squire Blackburn, seconded by Squire Mueller, for second reading and approval of Ordinance #10-2022 amending the Table of Special Ordinances, Section 1 Zoning Map Changes of The Franklin County Code of Ordinances for a 4.09-Acre Property, being all of Lot 1, Parcel 2 as shown in Plat Cabinet M, slide 131, Further Identified as PVA Map #086-30-11-001.00, Located at the Intersection of Isaac Shelby Circle West and Metcalf Drive, from Limited Commercial District (CL) to Two Dwelling District (RD).
