The Franklin County Attorney was sworn in by The Honorable Phillip Shepherd, Franklin County Circuit Judge, at a ceremony held on January 3, 2023 at 10:00 a.m.)

Franklin County Fiscal Court met on Tuesday, January 3rd, 2023. The meeting was streamed live by Frankfort Plant Board, Cable Channel 10, Franklin County Fiscal's Court's Official Facebook page, www.facebook.com/fcfcky and Franklin County Fiscal Court's Official YouTube channel, www.tinyurl.com/fcfcky. The meeting was made available for video teleconference (VTC) participation with the primary location and public authorization area in the Fiscal Court Conference Room located at 321 West Main Street.

The meeting was called to order at 5:01 pm with Judge Michael Mueller presiding. The following members of Fiscal Court were present: Squire Sherry Sebastian, Squire J.W.
