Franklin County Fiscal Court met on Thursday, June 22, 2023. The meeting was streamed live by Frankfort Plant Board, cable channel 10, Franklin County Fiscal Court's Official Facebook page, www.facebook.com/fcfcky, and Franklin County Fiscal Court's Official YouTube channel, www.tinyurl.com/fcfcky. The meeting was made available for video teleconference (VTC) participation with the primary location and public observation area in the Fiscal Court Conference Room located at 321 West Main Street.

The meeting was called to order at 7:29 p.m. with Judge Michael Mueller presiding. The following members of the Fiscal Court were present: Squire Sherry Sebastian, Squire J.W. Blackburn, Squire Kelly Dycus, Squire Scotty Tracy, Squire Richard Tanner, and Squire Eric Whisman. County Attorney Max Comley was in attendance.

Motion by Squire Blackburn, seconded by Squire Sebastian, for authorization to open admin code and direct the administrative services committee to meet and recommend changes to be brought back before this body. Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, Tanner, Whisman, and Judge Mueller. Motion passed.

Following roll call, motion by Squire Sebastian, seconded by Squire Whisman, for authorization for approval of minutes from the special joint meeting of June 6, 2023. Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, Tanner, Whisman, and Judge Mueller. Motion passed.

Motion by Squire Sebastian, seconded by Squire Whisman, for authorization for approval of amended minutes from the regular meeting of June 7, 2023. Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, Tanner, Whisman, and Judge Mueller. Motion passed.

Motion by Squire Sebastian, seconded by Squire Blackburn, for authorization to approve an agreement between Atom Chemical and Franklin Couty Regional Jail for Preventive Maintenance and Monthly Service. Voting in favor of the motion were Squires Sebastian, Blackburn, Tracy, Tanner, Whisman, and Judge Mueller. Motion passed.

Motion by Squire Tanner, seconded by Squire Sebastian, for authorization to approve an agreement with Kentucky Interactive LLC and Franklin County Fiscal Court regarding Credit/Debit Card and ACH Transaction Processing. Motion by Squire Sebastian, seconded by Squire Tracy, for second reading and approval of an Ordinance #6-2023 amending the Table of Special Ordinances, section 1 Zoning Map Changes of the Franklin County Code of Ordinances for a 4.996-acre property, identified as PVA Map #049-00-00-020.00), located at 209 Devils Hollow Road from Rural Residential B District (RB) to Industrial Commercial District (IC). Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, and Tanner. Votion in opposition were Squire Whisman and Judge Mueller. Motion passed.

Motion by Squire Tracy, seconded by Squire Sebastian, for authorization to award a bid for deicing salt to the best bidder, Morton Salt Inc. Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, Tanner, Whisman, and Judge Mueller. Motion passed.

Motion by Squire Sebastian, seconded by Squire Dycus, for authorization to approve the Franklin County Health Department contract for preventative services for all county government employees including firefighter physicals from July 1, 2023, to June 30, 2024. Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, Tanner, Whisman, and Judge Mueller. Motion passed.

Motion by Squire Sebastian, seconded by Squire Dycus, for seconding reading and approval of Amendment #2 Ordinance #5-2022 Relating to Budget for Fiscal Year 2022-2023. Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, Tanner, Whisman, and Judge Mueller. Motion passed.

Motion by Squire Sebastian, seconded by Squire Dycus, for second reading and approval of an Ordinance #7-2023 relating to the Budget for Fiscal Year 2023-2024. Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, Tanner, and Judge Mueller. Voting in opposition were Squire Whisman. Motion passed.

Motion by Squire Sebastian, seconded by Squire Tanner, for authorization to approve Budget Transfers for Fiscal Year 2022-2023. Voting in favor of the motion were Squires Sebastian, Blackburn, Dycus, Tracy, Tanner, and Judge Mueller. Voting in opposition were Squire Whisman. Motion passed.
