Franklin County Fiscal Court met on Tuesday, November 21, 2023. The meeting was made available for video teleconference (VTC) participation with the primary location and public observation area in the Fiscal Court Conference Room located at 321 West Main Street.

The meeting was called to order at 7:11 p.m. with Judge Michael Mueller presiding. Authorization to approve an Interlocal Cooperation Agreement with the City of Frankfort providing for the County of Franklin to Provide Code Enforcement Services in the City was tabled.

Motion by Squire Sebastian, seconded by Squire Dycus, for Second Reading and Approval of an Ordinance #16-2023 amending Chapter 30 Administrative Code Chapter 30, §30.096 of The Franklin County Code of Ordinances to Remove and Add Language under Subsections (A), (B), (C) and Adding (D) relating to Employee Evaluation. Voting in favor of the motion were Squires Sebastian, Dycus, Tracy, Tanner, Whisman, and Judge Mueller. Motion passed.

First Reading of an Ordinance amending The Table of Special Ordinances, Section 1 Zoning Map changes of The Franklin County Code of Ordinances for a 3.13-acre tract from Industrial Commercial District (IC) to Highway Commercial District (CH). The property is identified as PVA MAP #050-00-092.03, located at 1003 and 1005 Twilight Trail.
