Dear Proprietor:

We would like to inform you of an important update regarding the Local Transient Room Tax (TRT) in Franklin County. The Franklin County Fiscal Court recently approved changes to the TRT that will take effect on July 1, 2025.

Under the current system, Franklin County collects a 3% TRT on properties in the unincorporated areas and a 2% Fine Arts Center Transient Tax (FACT) on all properties within the county.

Key Changes Effective July 1, 2025:

- The 3% TRT will no longer be collected for properties in the unincorporated areas of Franklin County.
- A new 6% TRT will be implemented across all properties in Franklin County. The tax collected will be allocated as follows:
 - o 3% for the Sports Tourism Commission
 - o 2% for the Fine Arts Center
 - o 1% placed in escrow for a convention center
- Reporting and payments will be due on a monthly basis, rather than quarterly. All proprietors will be required to submit a monthly report, regardless of whether or not they use an online booking platform.
- If you are using an online booking platform, you will need to coordinate with them to make the necessary adjustments.

This ordinance applies specifically to Franklin County TRT. If you have questions about additional TRT for properties within the city limits of Frankfort, please contact the City of Frankfort for further information.
