

ORDINANCE NUMBER 7 - 2021

COUNTY OF FRANKLIN, KENTUCKY

AN ORDINANCE AMENDING THE ADMINISTRATIVE CODE OF THE FRANKLIN COUNTY CODE OF ORDINANCES CHAPTER 30 TO ADD LANGUAGE UNDER NEW SUBSECTIONS COUNTY SERVICES §30.159, §30.160, §30.161, §30.162, §30.163, §30.164, §30.165, §30.166, §30.167, §30.168, AND §30.169 (A), AND (B)

WHEREAS, The Franklin County Fiscal Court adopted the General Administration Section of Chapter 30: Administrative Code by Ordinance No. 1-2021 on the 19th day of February, 2021, to establish procedures and processes relating to the Constitutional office of the Franklin County Judge Executive; and

WHEREAS, the Judge Executive has established an Administrative Service Committee consisting of two Magistrates and the Judge Executive to consider amendments to the Administrative Code; and

WHEREAS, The Administrative Service Committee has met and considered changes relating to the General Administrative Section of Chapter 30: Administrative Code of the Franklin County Code Ordinances relating to the office of Judge Executive; and

WHEREAS, the Administrative Service Committee desires consideration by the Fiscal Court the General Administrative Section of Chapter 30: Administrative Code of the Franklin County Code Ordinances relating to the office of Judge Executive

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF FRANKLIN, COMMONWEALTH OF KENTUCKY, THAT:

SECTION I. The Code of Ordinances, Administrative Code, Chapter 30, **§30.159 (A) is hereby amended to read as follows:**

§ 30.159 SHERIFF SERVICES

(A) Goals and Objectives: The Franklin County Sheriff's Office is responsible for the performance of various duties relating to the protection of life and property, enforcement of criminal and traffic laws, prevention of crime, preservation of the public peace, and the apprehension of criminals.

SECTION II. The Code of Ordinances, Administrative Code, Chapter 30, **§30.160 (A) is hereby amended to read as follows:**

§ 30.160 ROAD DEPARTMENT

(A) Goals and Objectives: The Road Department shall be responsible for the maintenance, construction, and upkeep of all roads and bridges in the County Road System. The County Road Engineer/Supervisor shall head this Department.

SECTION III. The Code of Ordinances, Administrative Code, Chapter 30, §30.161 (A) is hereby amended to read as follows:

§ 30.161 COUNTY ROAD SYSTEM

(A) The FCFC shall designate by Resolution which roads in the County will be on the County Road System and maintained by the County Road Department. Those roads so designated shall include for County maintenance, but not limited to the following all appurtenant bridges, side ditches, headwalls, culverts, guard rail systems, signage and traffic control devices unless specifically excluded by an agreement.

SECTION IV. The Code of Ordinances, Administrative Code, Chapter 30, §30.162 (A) is hereby amended to read as follows:

§ 30.162 PARKS AND RECREATION

(A) Goals and Objectives: To provide quality recreational services to all citizens and visitors of Franklin County.

SECTION V. The Code of Ordinances, Administrative Code, Chapter 30, §30.163 (A) and (B) is hereby amended to read as follows:

§ 30.163 CONTENTS OF PLANNING AND SUBDIVISION REGULATIONS

(A) The County shall provide for comprehensive planning and the implementation of subdivision guidelines by County ordinance where not covered by KRS.

(B) Building and Electrical Inspections, as required by state law, shall be provided by the FCFC with duly appointed inspectors through the County Planning, Zoning and Building Codes Department.

SECTION VI. The Code of Ordinances, Administrative Code, Chapter 30, §30.164 (A) and (B) is hereby amended to read as follows:

§ 30.164 LAW ENFORCEMENT POLICIES

(A) The Franklin County Sheriff's Department shall develop a "pursuit driving" policy, for the purpose of effectuating potential arrest or responding to any emergency situation, a use of deadly force policy, and a use of physical force policy, and provide same to the FCFC for review.

(B) The Sheriff shall forward any policy revisions to the FCFC.

SECTION VII. The Code of Ordinances, Administrative Code, Chapter 30, §30.165 (A) is hereby amended to read as follows:

§ 30.165 JAIL POLICIES

(A) This Administrative Code shall be attached to the Franklin County Regional Jail Policies and Procedures and shall cover any and all areas not stipulated in the Franklin County Regional Jail Policies and Procedures.

SECTION VIII. The Code of Ordinances, Administrative Code, Chapter 30, §30.166 (A) is hereby amended to read as follows:

§ 30.166 FIRE DEPARTMENT

(A) The County Fire Department is responsible for firefighting and emergency response in the unincorporated areas of the county. The Fire Department also supports the City Fire Department when the situation dictates.

SECTION IV. The Code of Ordinances, Administrative Code, Chapter 30, §30.167 (A) is hereby amended to read as follows:

§ 30.167 PLANNING/ZONING/CODE ENFORCEMENT OFFICE

(A) This office provides building and electrical inspections for all new construction within the county. It utilizes the Kentucky Building Code, ~~the CABO One and Two-Family Dwelling Code~~ the Kentucky Residential Code and the National Electric Code. The office also provides planning and zoning services for the residents of the county, as well as performing administration of the County Zoning Ordinance (Ord. 7, 2001 Series, amending Ord. 2, 1993 Series, electrical fees) (Ord. 6, 2001 Series, amending Ord. adopted 6-23-1998), which may be amended as required by state law then in effect and to which reference is made for particular amendments.

SECTION X. The Code of Ordinances, Administrative Code, Chapter 30, §30.168 (A) is hereby amended to read as follows:

§ 30.168 OCCUPATION TAX OFFICE

(A) This office collects and maintains occupational license fees, maintains a listing of all businesses conducting business within the county, receives all occupational taxes and posts it to appropriate accounts and collects all delinquent occupational license fees (Ord. 14, 2007 Series, as amended, and as may be

amended by any future amendments, which are hereby ratified and for which reference is made for additional requirements).

SECTION XI. The Code of Ordinances, Administrative Code, Chapter 30, §30.169 (A) and (B) is hereby amended to read as follows:

§ 30.169 LAKEVIEW PARK

(A) The county's Lakeview Park was established in July 1991. It is 135 acres of rolling landscaped grassland on Georgetown Road, Hwy. 460. The main attraction of the park is the Carter House, a two-story brick colonial style home named for the former owners of the Carter family farm. The Park also includes pavilions, softball complexes, soccer fields, horse show rings, a walking/running path, playground and a nine-hole, par 3 family golf complex and driving range.

(B) The County Lakeview Park Rental Policy is adopted on 10-30-1997, in Fiscal Court Order Book 17, page 326, and as may be amended by any future amendments, which are hereby ratified and for which reference is made for additional requirements.

SECTION XII. CODIFICATION. The provisions of Section I of this Ordinance shall be published as appropriate in the Franklin County Code of Ordinances as soon as practicable.

SECTION XIII. SEVERABILITY CLAUSE. If any section, part of provision of this Ordinance is declared unconstitutional or invalid by a court of competent jurisdiction, then it is expressly provided and it is the intention of the Franklin County Fiscal Court in passing this Ordinance that its parts shall be severable and all other parts of this Ordinance shall not be affected thereby and they shall remain in full force and effect.

SECTION XIV. PUBLICATION AND EFFECTIVE DATE. This Ordinance shall take effect immediately upon its passage and publication according to law.
